Dear Virginia Educator,

Here are the equipment loan form(s) for the 2009-2010 Biotech-in-a-Box program. As always, please complete the entire form for each kit that you are requesting.

What's new this year? We've gone paperless on the confirmations and manuals. Loan confirmations will be by email, and the manuals will be sent on CD. The overheads (in Powerpoint format) will also be on the CD. If this is a hardship, please let me know that you would like the actual overheads sent with your kit(s).

We've added some equipment, thanks to a grant from the Virginia Council on Advanced Technology Skills (VCATS), in partnership with the Virginia Biotechnology Association (VaBIO) and the Virginia Manufacturers Association (VMA). We are very grateful for their support. We have purchased two new (fancy!) thermal cyclers, which will give us three in the loan program. We have also added a ninth DNA kit, and all the equipment should be standardized in both the DNA and Protein Electrophoresis kits, a goal we have had for some time.

At some time during the summer, I am planning another of my periodic surveys of equipment borrowers. Before you shudder in dread, this one will be on line and should take very little of your time. I appreciate the feedback on the program, and I need to know what equipment and supplies are actually being used (and what else is needed).

Now, to the forms. I know, this doesn't change from year to year, but there are several important points here. First, **please, please** check the kit when it arrives, not 10 minutes before you plan to use it. We are human, and make mistakes. (I have super workstudy students, two of whom used the kits in high school!!) If there is something missing from the kit, I can get it to you in less than 24 hours *if I know about it!*

I've changed the forms a little this year. There is only a single sheet for your contact information, and the kit specific information is all on the date form. Please make sure that you provide all of the requested information.

When filling out the forms, *please* provide multiple date choices. We try to give everyone a loan date that fits his or her schedule, but it is difficult without a number of dates with which to work. The prospect of getting your top choice loan dates is greatly improved by returning your forms on time. Last year, of the requests received by the beginning of August, 96% of borrowers got either their first or second choice dates.

If there are multiple teachers at your school who wish to use the DNA Biotechnology Kit, the thermal cycler, or the Protein Electrophoresis Kit, please coordinate your equipment requests. We will not be able to ship these kits to a school more than one time during the academic year. You might consider requesting the Thanksgiving time slots, as these are usually longer. (For our records, please send a request form for each teacher planning to use the equipment, but send the forms in together.)

Other notes:

1. **Cancellations.** Please let us know before the shipping date if your schedule will not permit using the kit as planned.
2. **Thermal cycler.** Please remember that this is the thermal cycler only, not a kit. If you need the thermal cycler at the same time you have the DNA Biotechnology Kit, please chose compatible loan slots, and include a note on both loan forms indicating that you would like the loans to be concurrent.

3. **Protein Electrophoresis Kit.** If you purchase extra gels from Bio-Rad, the Center will, upon request, provide buffers, etc., for up to 10 additional gels.
4. **Loan duration.** Except for the Immunology Kit, all loans are for two weeks. Please keep to the schedule and return the kit on time. If you need an extension, please contact us and we will accommodate your request *if possible*.

You may return the loan request(s) to me by email attachment, fax, or mail. Initial scheduling for the 2009-2010 academic year will be completed by August 19, 2009, so please return loan form(s) by August 3, 2009, to have your request considered at that time. Requests received after that time will be filled on a space-available basis. If you have not received confirmation of your reservation by August 31, 2009 (or, if submitted after that date, within 2 weeks of sending request), please call or email to confirm that your request has been received.
